

At this stage we want you to gain clarity in what the actual issues of the case are. ## Q: What is a Parenting Plan?



# Child Support Financial Statement Form:

To figure the monthly amount of expenses, weekly should be multiplied by 4.3 and yearly expenses should be divided by 12. If you do not pay the same amount each month for any of the the categories listed, figure what your average monthly expenses is.

**Total Monthly Income:** Include income from all the sources including selfemployment rent, royalties, business income, salaries, wages, commissions, bunoses, dividends, pensions, interest, trust, annulties, social security benefits, workers compensation, unemployment benefits, disability benefits, alimony or maintenance received, tips, income from side jobs, sevence pay, capital gains, gifts, prizes, lottery winnings, etc. Do no report benefits from means-tested public assistance programs such as food stamps or AFDC.

**Extraordinary Medical Expenses:** Uninsured expenses over \$100 for single illness or condition including orthodontia, dental treatment, asthma treatment, physical therapy, treatment for any chronic health problems, and professional counseling or psychiatic therapy for diagnosed mental disorders.

**Child Care Expenses:** Actual child care expenses incured on behalf of a child due to employment or job search of either parent with amount to be determined by actual experience of the level required to provide quality care from a licensed source.

**School and transportation Expenses:** Any expenses for attending a special or private elementary or secondary school to meet the particular needs of the child and expenses for transportation of the child between the homes of the parents.

Regardless of any agreement you may have reached, the courts will look to determine the "best interests" of the child. They look at several factors. No single factor is most important. This is a list of some, but not all, of the factors, that courts will consider.

**Material Opportunity** - Which parent has the financial resources to give the child more things?

Agreements - Is there a custody agreement already in place?

**Any Prior Abandonment or Surrender of Custody** - Is there a history of one parent walking out and leaving the other parent to cope with the child and the home? Which parent left when you last broke up?

**Religious Views** - These will be important in the court's decision only if you can show that religious views affect the physical or emotional well-being of the child.

**Ability to Maintain Family Relationships** - Who will be best able to help the child keep family relationships? Who is going to let the child speak with their ex-mother-inlaw, for example? Who will not penalize the child for any bad action on the part of the other parent?

Age, Health and Gender of Child

Length of Separation - How long has the parent been separated from the child?

Regardless of any agreement you may have reached, the courts will look to determine the "best interests" of the child. They look at several factors. No single factor is most important. This is a list of some, but not all, of the factors, that courts will consider.

**Primary Care Giver** - Who is the person who takes care of the child? Who feeds the child, shops for their clothes, gets them up for school, bathes them, and arranges day care? Who does the child turn to when they get hurt?

**Child Preference** - The decision of the court may be reversed on appeal if the judge will not hear the child's preference. However, the judge may choose to interview the child outside the presence of the parents. Though it is rare, the court will hear from a child under 7 years, and a child as young as 5 or 6 years of age may be heard. The child's maturity, and whether the child can tell the truth from fiction will guide the decision whether a child may be heard. A child of at least 10 or 12 years of age is certainly entitled to have their opinions heard and given weight in legal proceedings about custody. Additionally, the court has the power to appoint an attorney for the child in contested cases.

**Residences of Parents and Opportunity for Visitation** - How close do the parents live to each other? How close do they live to members of the child's extended family? Which parent lives closest to the child's school and social circle?

#### **Character and Reputation**

**Disability** - A party's disability is only relevant to a custody decision if the disability affects the best interest of the child.


